

# Surface Cleaner



#### **GENERAL INFORMATION**

155 Surface Cleaner is a slow flashing product designed for surface preparation before sanding and body work and as a final surface prep/cleaner before application of a topcoat. Removes: grease, oil, wax, silicone, adhesives, tar, dirt, sanding residue, and dust.



# 1. SUBSTRATES

- Unsanded surfaces
- OEM finishes
- Cured sealers
- Sanded surfaces
- Sanded primers



## 2. APPLICATION

- · Wash surface with mild detergent and water.
- · Rinse and dry surface.
- Soak clean cloth with 155 Surface Cleaner.
- Wipe surface with 155 Surface Cleaner and wipe dry with clean cloth before product dries.

### 3. TECH TIPS

- 155 Surface Cleaner should not be allowed to dry on the surface. If this occurs, re-apply 155 Surface Cleaner using a clean cloth, and wipe dry.
- For sensitive surfaces use 170 AquaClean
- Always replace cap after use.
- Not recommended for plastics.
