LORD Fusor® 800EZ/801EZ/802EZ/803EZ Factory Match Urethane Sealer/Adhesive

LORD Fusor® 800EZ/801EZ/802EZ/803EZ factory match urethane sealer/adhesive duplicates a factory appearance on standing seams, cosmetic seams, truck bed seams, tooled door skin seams, floor pan seams, core support seams, brushed seams and other applications in which a non-sag cosmetic seam sealer is required.

LORD Fusor urethane sealer/adhesive is available in the following colors:

- Neutral – LORD Fusor 800EZ and 801EZ Sealer/Adhesive
- White – LORD Fusor 802EZ Sealer/Adhesive
- Black – LORD Fusor 803EZ Sealer/Adhesive

Usage

1. Clean the area to be sealed with LORD Fusor plastic & rubber cleaner (Stock #703) (see Illustration A).
2. Sand and prime all bare metal areas. Allow primer to cure according to manufacturer's recommendations.
3. Scuff-sand or scratch-pad the primed area to be sealed.
4. Apply LORD Fusor 800EZ/801EZ/802EZ/803EZ urethane sealer/adhesive. Tool or acid brush the sealer/adhesive to the desired texture (see Illustration B).

Note: Do not use solvents for tooling the seam sealer as this may inhibit the curing characteristics of the product. Water may be used for tooling purposes.

5. Allow sealer/adhesive to cure for 10 minutes.
6. Prime and paint per manufacturer's recommendations.

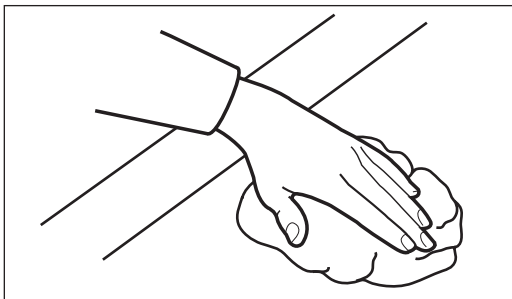
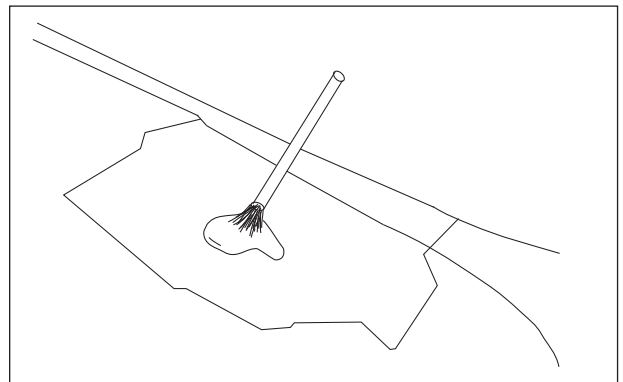
